# Sport Parent Code of Conduct

---

We, the Statesboro Bulloch County Park & Recreation Department, have implemented the following Sport Parent Code of Conduct for the important message it holds about the proper role of parents in supporting their child in sports. Parents should read, understand and sign this form prior to their children participating in our league.

Any parent guilty of improper conduct at any game or practice will be asked to leave the sports facility and be suspended from the following game(s). Repeat violations may cause a multiple game suspension, or the season forfeiture of the privilege of attending all games.

## *Preamble*

The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles:

- Trustworthiness
- Respect
- Responsibility
- Fairness
- Caring
- Good Citizenship

The highest potential of sports is achieved when competition reflects these "six pillars of character."

## *I therefore agree:*

1. I will not force my child to participate in sports.
2. I will remember that children participate to have fun and that the game is for youth, not adults.
3. I will inform the coach of any physical disability or ailment that may affect the safety of others.
4. I will learn the rules of the game and the policies of the league.
5. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sports event.
6. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official,

coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.

7. I will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
8. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
9. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.
10. I will teach my child to do one's best.
11. I will praise my child for competing fairly and trying hard.
12. I will never ridicule or yell at my child or other participants for making a mistake or losing a competition.
13. I will emphasize skill development and practices and how they benefit my child over winning. I will also de-emphasize games and competition in the lower age groups.
14. I will promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win.
15. I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place.
16. I will demand a sports environment for my child that is free from drugs, tobacco, and alcohol and I will refrain from their use at all sports events.
17. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.

# Concussion

## INFORMATION SHEET



This sheet has information to help protect your children or teens from concussion or other serious brain injury. Use this information at your children's or teens' games and practices to learn how to spot a concussion and what to do if a concussion occurs.

### What Is a Concussion?

A concussion is a type of traumatic brain injury—or TBI—caused by a bump, blow, or jolt to the head or by a hit to the body that causes the head and brain to move quickly back and forth. This fast movement can cause the brain to bounce around or twist in the skull, creating chemical changes in the brain and sometimes stretching and damaging the brain cells.

### How Can I Help Keep My Children or Teens Safe?

Sports are a great way for children and teens to stay healthy and can help them do well in school. To help lower your children's or teens' chances of getting a concussion or other serious brain injury, you should:

- Help create a culture of safety for the team.
  - Work with their coach to teach ways to lower the chances of getting a concussion.
  - Talk with your children or teens about concussion and ask if they have concerns about reporting a concussion. Talk with them about their concerns; emphasize the importance of reporting concussions and taking time to recover from one.
  - Ensure that they follow their coach's rules for safety and the rules of the sport.
  - Tell your children or teens that you expect them to practice good sportsmanship at all times.
- When appropriate for the sport or activity, teach your children or teens that they must wear a helmet to lower the chances of the most serious types of brain or head injury. However, there is no "concussion-proof" helmet. So, even with a helmet, it is important for children and teens to avoid hits to the head.



**Plan ahead.** What do you want your child or teen to know about concussion?

### How Can I Spot a Possible Concussion?

Children and teens who show or report one or more of the signs and symptoms listed below—or simply say they just "don't feel right" after a bump, blow, or jolt to the head or body—may have a concussion or other serious brain injury.

#### Signs Observed by Parents or Coaches

- Appears dazed or stunned
- Forgets an instruction, is confused about an assignment or position, or is unsure of the game, score, or opponent
- Moves clumsily
- Answers questions slowly
- Loses consciousness (even briefly)
- Shows mood, behavior, or personality changes
- Can't recall events *prior to* or *after* a hit or fall

#### Symptoms Reported by Children and Teens

- Headache or "pressure" in head
- Nausea or vomiting
- Balance problems or dizziness, or double or blurry vision
- Bothered by light or noise
- Feeling sluggish, hazy, foggy, or groggy
- Confusion, or concentration or memory problems
- Just not "feeling right," or "feeling down"

**Talk with your children and teens about concussion.** Tell them to report their concussion symptoms to you and their coach right away. Some children and teens think concussions aren't serious, or worry that if they report a concussion they will lose their position on the team or look weak. Be sure to remind them that *it's better to miss one game than the whole season.*



## CONCUSSIONS AFFECT EACH CHILD AND TEEN DIFFERENTLY.

While most children and teens with a concussion feel better within a couple of weeks, some will have symptoms for months or longer. Talk with your children's or teens' healthcare provider if their concussion symptoms do not go away, or if they get worse after they return to their regular activities.

### What Are Some More Serious Danger Signs to Look Out For?

In rare cases, a dangerous collection of blood (hematoma) may form on the brain after a bump, blow, or jolt to the head or body and can squeeze the brain against the skull. Call 9-1-1 or take your child or teen to the emergency department right away if, after a bump, blow, or jolt to the head or body, he or she has one or more of these danger signs:

- One pupil larger than the other
- Drowsiness or inability to wake up
- A headache that gets worse and does not go away
- Slurred speech, weakness, numbness, or decreased coordination
- Repeated vomiting or nausea, convulsions or seizures (shaking or twitching)
- Unusual behavior, increased confusion, restlessness, or agitation
- Loss of consciousness (passed out/knocked out). Even a brief loss of consciousness should be taken seriously

### What Should I Do If My Child or Teen Has a Possible Concussion?

As a parent, if you think your child or teen may have a concussion, you should:

1. Remove your child or teen from play.
2. Keep your child or teen out of play the day of the injury. Your child or teen should be seen by a healthcare provider and only return to play with permission from a healthcare provider who is experienced in evaluating for concussion.
3. Ask your child's or teen's healthcare provider for written instructions on helping your child or teen return to school. You can give the instructions to your child's or teen's school nurse and teacher(s) and return-to-play instructions to the coach and/or athletic trainer.

Do not try to judge the severity of the injury yourself. Only a healthcare provider should assess a child or teen for a possible concussion. Concussion signs and symptoms often show up soon after the injury. But you may not know how serious the concussion is at first, and some symptoms may not show up for hours or days.

The brain needs time to heal after a concussion. A child's or teen's return to school and sports should be a gradual process that is carefully managed and monitored by a healthcare provider.

▶ **Children and teens** who continue to play while having concussion symptoms, or who return to play too soon—while the brain is still healing—have a greater chance of getting another concussion. A repeat concussion that occurs while the brain is still healing from the first injury can be very serious, and can affect a child or teen for a lifetime. It can even be fatal.

## RETURN TO PLAY POLICY

If a youth athlete is removed from play, and the signs and symptoms cannot be readily explained by a condition other than concussion, the coach or other designated personnel shall notify the Bulloch County Recreation and Parks staff. Bulloch County Recreation and Parks shall not permit the youth to return to play or participate in any supervised team activities involving physical exertion games, competitions, tryouts or practices that day and until the youth athlete is evaluated by a health care provider. Bulloch County Recreation and Parks must receive written clearance from the health care provider for a full graduated return to play.

“Health Care Provider” means a licensed physician or another licensed individual under the supervision of a licensed physician, such as a nurse practitioner, physician assistant or athletic trainer, who has received training in neuropsychology or concussion evaluation and management.

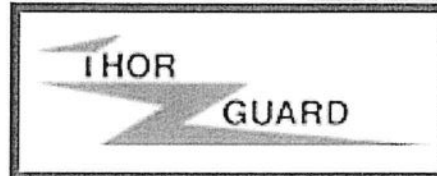


# Thor Guard Lightning Prediction System

**“A Proactive Solution for Lightning Safety”**

## How it Works

- \* Sensors measure and analyze the electrostatic fields in the atmosphere
- \* Predicts the possible occurrence of lightning 8 - 20 minutes before it could potentially strike



## Operational Statistics

- \* The system has a coverage area radius of 2.5 miles
- \* It is 97% accurate within a 2-mile radius
- \* System operates seven days per week, from 8am - 9:30pm in the months of March - November.

## When a Threat is Detected

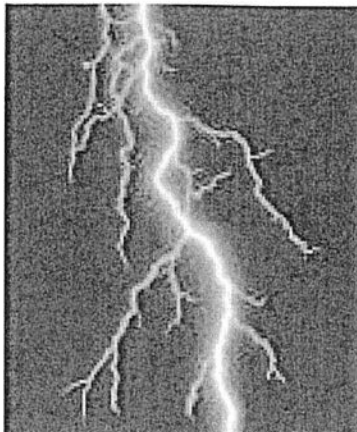
- \* Warning horn will sound with an uninterrupted 15-second blast and a strobe light will flash when there is the potential for a lightning strike within the coverage area
- \* Once a threat is detected, the system continuously updates data about energy in the air 50 times per second to see if the atmosphere still retains the potential energy necessary for a lightning strike
- \* Upon hearing the horn blast and/or seeing the strobe light, park users must leave the park and seek appropriate shelter

## What Qualifies as Appropriate Shelter

- \* Inside buildings, hard-top vehicles or other lightning protected facilities and amenities  
*As a Last Resort: Seek low-lying areas or dense woods*

## What to Avoid

- \* Open areas/isolated trees
- \* Water
- \* Metal
- \* Wire Fences
- \* Overhead wires/power lines
- \* Elevated ground
- \* Maintenance Machinery
- \* Open top or soft top vehicles



## When the Threat has Diminished

- \* The horn will sound three short 4-second blasts and the strobe light will turn off
- \* The horn signals that normal activity may resume

## Thorguard Location

- \* near pond at Mill Creek Regional Park

## Other Non-covered Locations

- \* Signal horns may not be at your site, but at a site within ear shot. If you hear the alarm, please leave the park immediately.

## **BULLOCH COUNTY RECREATION AND PARKS DEPARTMENT MINOR BASEBALL RULES**

The Bulloch County Recreation and Parks Department offers this league for all boys age nine and ten. This handout contains only those rules specific to the Minor Baseball league.

These rules are divided into the following sections: Eligibility, Game/Field Provisions, Equipment, Conduct, Coaches Responsibilities, Participation and Game Rules, League Rankings.

### **Section A – Eligibility**

1. The age of the participant on August 31<sup>st</sup> will determine which age division he will play in.
2. Age Classification for Minor Baseball is 10 & under prior to September 1<sup>st</sup> of the current year.

### **Section B - GAME/FIELD PROVISIONS**

1. A regulation game shall consist of six (6) innings or a one (1) hour and 15 minute time limit (75 minutes).
2. A game tied after regulation play will remain a tie
3. The score for a forfeited game shall be recorded as 7-0.
4. A game shall be considered complete with one team ahead after five (5) innings by eight (8) runs, four (4) innings by twelve (12) runs, or three (3) innings by fifteen (15) runs.
5. Line-ups shall be given to the official scorekeeper ten minutes prior to game time.
6. The home team sits on the first base side of the field. The home team is the team listed on the right side of the schedule.
7. Pitching Distance 46':
  - The Recreation Department will set up the pitching machine
  - Pitching machine speed will be set at 40 mph..
8. Base distance is sixty feet (60').
9. No infield practice will be allowed before or in between games.
10. A 5-foot line will be placed behind the back of the batters box and the ball must cross that line before runners can steal a base.

### **Section C - EQUIPMENT**

1. The official bat shall be round, and made of wood, metal, or other material acceptable for batting as approved by the National Federation. Bats must not exceed thirty-three (33") in length, and two and five-eighths inches (2 5/8") in diameter. Approved bats must have the "USA Baseball" approved stamp to be eligible for SBCPRD recreation league play.

2. All players should be in full uniform issued by the BCRP. It includes a cap, team shirt, and the gray pants that are to be purchased by the participant.
3. Shoes are mandatory. Steel spikes are not allowed. Cleats are optional
4. No jewelry may be worn. Braces must be wrapped with an ace bandage.

#### **Section D - CONDUCT**

1. There will be no hollering or harassing the players on the opposing team by parents, spectators, managers, players, or coaches. The person(s) violating this rule shall be suspended from the following game. (This is determined by the judgment of the officials and/or the recreation field supervisor).
2. Any player throwing a bat, helmet, etc. will be warned the first time, and will be called out the second time. If the situation is flagrant, no warning may be granted and the player may be ejected (umpire's judgment). It is the responsibility of the coach to notify the players of this rule.
3. Any player, coach, or spectator acting in an unsportsmanlike manner, or in any way that could prove detrimental to the league players, umpires, staff, or spectators will be subject to disciplinary action by the Recreation Department.
4. **No use of any tobacco products is allowed on the premises of any BCRP Facility.**

#### **Section E - COACHES RESPONSIBILITIES**

1. Only certified coaches designated by the Recreation Department will be allowed in the dugout. Coaches shall not leave the dugout except to coach bases or confer (charged time conferences) with players or umpires. All persons entering the dugout shall be players or a designated & certified coach. Only head coaches shall confer with the umpire, and then for only one minute during a charged conference granted by the umpire. A coach or assistant coach may stand outside of the dugout to instruct the defensive team.
2. If a player does not play for disciplinary reasons, it is the responsibility of the coach to notify the Athletic Supervisor first, the field supervisor second, then the opposing coach and the umpire at the game. Coaches must notify the Recreation Department office in the event of an injury to any player, whether the accident occurs during practice or during a game.
3. Unless contacted by the Recreation Department, all teams must show up at the field for games. If halted by inclement weather, teams must stay until a staff person releases them. Contact the hotline at 489-2087 on game days for information regarding cancellations. Complete game is three (3) full innings or thirty-eight (38) minutes.
4. **There will be no intentionally hitting balls against any facility fencing.**

#### **Section F - PARTICIPATION**

1. It is recommended that each player should play at least three innings on defense per game, and recommended that all substitutes (who have not been in the game) enter the game at or before the fourth inning or after thirty (30) minutes of time has expired, whichever occurs first.
2. If any player does not play for disciplinary reasons or if she or he is unwilling or unable to play half of a match, it is the responsibility of the coach to notify the field supervisor. Coaches not playing their players the required time will receive:  
1<sup>st</sup> offense: Verbal warning

2<sup>nd</sup> offense: Written warning

3<sup>rd</sup> offense: Suspension of coaching duties

\*\*\*Any confirmed violations may result in immediate dismissal.

3. **A team must start and finish with a minimum of seven players.**
4. All players present must be listed in the batting order and any ten (10) may play defense. If a player is late, he must be placed in the last space in the batting order. Free substitution on defense.
5. It is the parent's responsibility to get their child to practice and games or contact the coach. If a coach is not contacted, he/she may bench the players.
6. If a player has attended or missed practice with a valid excuse, he should play a minimum of three innings. If a player misses practice without a valid excuse, he may not start the next game and may not play more than three (3) innings on defense.

### Section G - GAME RULES

1. All teams must use a catcher. Catchers must wear full protective equipment including mask, protective helmet, body protector, and shin guards (provided by the Recreation Department). **Protective cup in athletic supporter is mandatory (to be provided by the participant).**
2. All batters and baserunners must wear the helmet unless in the dugout. C-flaps are approved (Facemasks are optional). If the helmet is removed, the player and both teams will be warned. The next helmet violation may result in an out. If the helmet falls off, there is no penalty, but a smaller helmet will be required before the next pitch.
3. The infield fly rule is not in effect.
4. Ten batters (10) or three outs (3) will constitute an inning. When the tenth batter comes to the plate, the official scorekeeper will tell the plate umpire, who will notify both teams. The inning will end by:
  - (1) When the tenth batter comes to the plate, this will be treated as if there are two outs.
  - (2) Any forced out or caught fly ball.
  - (3) The ball is in front of the runner closest to home plate so that no one can score.
  - (4) Retrieving the ball and touching home plate (on the tenth batter).
  - (5) A player will not be allowed to call time **inside the baseline**, as in Section G rule 6. An out will have to be made.
5. Each batter will be given six (6) pitches or three (3) strikes to put the ball in play. If a batter takes six (6) pitches or three (3) swings without putting the ball into play that batter will be out. A batter may continue to foul off the last pitch until he puts the ball in play or strikes out (includes taking a pitch).
6. Time will be granted under the following condition: The ball is in the possession of a player **inside the baseline** and no runner is half way to the next base. You cannot yell "time" while standing with the ball in the outfield.
7. The judgement decisions by an umpire of any play shall not be protested. Protest on misinterpretation of the rules is allowed to the umpire-in-chief if accepted as valid by the Recreation Department. The protesting manager must inform the head umpire of the protest at the time the infraction occurs, and shall list the points of protest before the next live ball. He/she must then continue the game under protest. The protesting manager must file a written protest at the Recreation Department by 5:00 p.m. the next working day. It is the hope of the Recreation Department that all situations in question can be resolved at the field and dismissed.



8. If a batted ball hits the pitching machine, cord, or umpire the ball is dead and the batter is awarded first base and all other baserunners advance one base.
9. On a passed ball at first base, the runner may advance to 2nd at the risk of being thrown out.
  - (1) If NO attempt is made to get the runner out at 2nd base, he/she may not advance any further.
  - (2) If an attempt is made the runner can advance as far as he/she can.
10. Any player unable to bat due to illness or injury will not be called out. His position in the batting order will be skipped. (The player with the illness or injury must be verified by the field supervisor and the player's parents). Once a player is declared injured or ill, he will not be allowed to reenter the game. The last runner to make an out may replace an injured base runner.
11. Three strikes constitute an out, and a batter is not allowed to run if the catcher misses or drops the third strike.
12. **Head first sliding is allowed.**
13. Base Stealing will be allowed with the following limitations:
14. **A 5 ft line will be chalked behind home plate and that line will connect with the outside chalk line of the batters boxes. If a ball goes past the back line or kicks to the right or left outside of the box, the runner may steal.**
  - A. The ball must pass the 5-foot line that is behind the batters box
  - B. A player cannot steal home
  - C. A base runner can steal only if the ball passes the catcher and then only one base advance is allowed.
    1. If a throw becomes an overthrow, the one-base advanced restriction still applies (ball is dead, no advance)
  - D. Runners must maintain contact with the base until the ball reaches or passes home plate (Penalty – out).
  - E. If a thrown ball hits the machine or umpire feeding the machine, each base runner is awarded one base.
15. All players are required to wear a protective facemask while playing the pitchers position.
16. A line shall be drawn in the infield at the same distance as the pitching distance. No infielder is allowed **in front of the restrictive line until after** the ball is delivered through the machine, outfielders remain in outfield grass area, and the pitcher must remain in the half circle.

Penalty:

  - A. The offense can choose to replay the pitch, or
  - B. The offense can choose to take the result of the play
17. There will be no intentional walks.
18. No Bunting.



## Section H – League Standings

1. League Standings will be determined by winning percentage.

Winning percentage is figured by wins/losses/ ties.

Win= 1 Point

Loss= 0 Point

Tie= .5 Point

The percentage is figured by Total Points divided by Total Games Played.

In the event of a tie in the league rankings the tie breaker will be head to head competition. If the teams remain tied after head to head competition, the next tie breaker would head to head record against the next highest ranked team in the league. Ex: record verses the #1 team, then #2 and so on until the tie is broken. This will continue down through the ranks until a winner is determined. If the teams remain tied after the head to head records a coin flip will be used to determine the winner.

### Tie Breaker

1. Head to head competition against the teams that are tied.
2. Head to head competition verses highest ranked teams  
Ex: record verses #1, then record verse #2 and so on down through the ranks
3. Coin flip

2. Season ending tournament will be seeded by league standings.
